The meeting will be held on **Monday, December 8, 2025, at 11:00 a.m.**

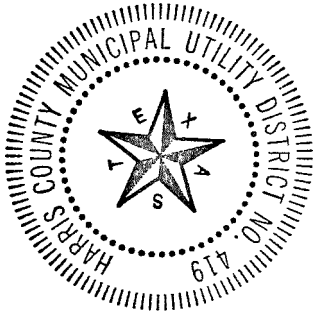
The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Receive public comments, including comments and requests submitted through the District's website, and matters of public interest;
2. Review and approval of the minutes of the meetings of the Board of Directors held on May 9, 2025, and November 10, 2025;
3. Consider election of officers and reorganization of the Board of Directors;
4. Approval of District Registration Form relative to election of officers;
5. Bookkeeper's report, including financial and investment reports and the payment of invoices presented;
6. Receive Tax Assessor-Collector report and approve payment of invoices presented and moving of accounts to uncollectible roll;
7. Report on legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, and the filing of proofs of claim;
8. Consider the future issuance of the District's final series of recreational bonds, and discuss same with the District's financial advisor;
9. Operator's Report, including:
 - a) Monthly report;
 - b) Repair and maintenance of District facilities;
 - c) Appeals of District charges and consideration of customer comments; and
 - d) Authorize operator and engineer to perform 2026 water loss audit;
10. Garbage Collection and Recycling Report from Republic Services, Inc.;

11. Engineer's Report, including:
 - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District;
 - b) Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District;
 - c) Status of construction of water, sewer and drainage facilities and paving to serve land within the District, including the approval of any pay estimates and/or change orders, and acceptance by Harris County of streets for maintenance, including:
 - i. Mason Road, Sections 8 and 9 – Water, Sewer and Drainage Facilities and Paving (Unitas Construction, Inc.);
 - d) Authorizing the design, advertisement, or award of construction contracts or concurrence in the award of contracts for the construction of recreational facilities within the District;
 - e) Status of construction of recreational facilities to serve land within the District, and the approval of any change orders, including:
 - i. Mason Road Section 9 Medians and Setbacks Landscape (Allgreen Associates);
 - f) Discussion regarding status of general landscaping improvements within the District, including review of proposals for maintenance of District facilities;
 - g) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, acceptance of facilities for operation and maintenance purposes, and conveyance of sites and/or facilities by the District;
 - h) Status of storm water permitting related to construction within the District, and the taking of action in connection therewith;
 - i) Status of acceptance by Harris County of streets and storm sewers for maintenance;
 - j) Discussion regarding Capital Improvements Plan and Summary of Costs for potential bond issuance, and authorize any action necessary in connection therewith; and
 - k) Discussion regarding alternative fencing options to serve the District's facilities;
12. Status of preparation of application to Texas Commission on Environmental Quality requesting approval for use of surplus funds and adoption of a Resolution authorizing same;
13. Matters related to the Bridgeland Water Agency (the "Agency") and directives to the District's Trustee and Alternate(s);
14. Updates and revisions to District website, including status of website administration through Touchstone District Services, LLC;
15. Developer's report;
16. Matters relative to Bridgeland Council, Inc. and/or Lakeland Village Homeowners' Association ("HOA"), including:
 - (a) Discussion regarding potential recreational facilities maintenance agreement with the HOA; and
 - (b) Status of repair of Oak Meadow Park bridge lighting;

14. Attorney's Report, including acknowledgement of Municipal Securities Rulemaking Board Rule G-10 disclosure received from Masterson Advisors LLC;
15. Schedule of future Board meetings; and
16. Matters for possible placement on future agendas.
