
The meeting will be held on Monday, July 14, 2025, at 11:00 a.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Receive public comments, including comments and requests submitted through the District's website, and matters of public interest;
- 2. Review and approval of the minutes of the meetings of the Board of Directors held on May 9, 2025, and June 9, 2025;
- 3. Bookkeeper's report, including financial and investment reports and the payment of invoices presented;
- 4. Receive Tax Assessor-Collector report and approve payment of invoices presented and moving of accounts to uncollectible roll;
- 5. Report on legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, and the filing of proofs of claim;
- 6. Operator's Report, including:
 - a) Monthly report;
 - b) Repair and maintenance of District facilities, including status of delivery and/or installation of Godwin pumps;
 - c) Appeals of District charges and consideration of customer comments; and
 - d) Approve purchase of educational materials for Water Smart program and any other action related to participation in said program;
- 7. Approval of contract with Si Environmental, LLC for operating services, transfer of District's operations services to Si Environmental, LLC, and authorize any action necessary in connection therewith;
- 8. Garbage Collection and Recycling Report from Republic Services, Inc.;
